# **Virginia**

While the litigation market is still down overall, lawyers in Virginia say it has picked up over the past year. Commercial litigation still lags, but intellectual property matters are picking up significantly, particularly in the Eastern District. Hoping to keep costs low, commercial clients are increasingly looking at arbitration and mediation to settle their disputes. Government contractors handle significant work within the state, leading to litigation, including increasing False Claims Act matters.

#### **Highly recommended firms**
